In recent times, the Indian Insurance industry has undergone numerous transformations with the regulator's vigilant and progressive plans in terms of innovations, new developments, modified regulations, and the vision of `Insurance for All' by 2047. During the year NIA conducted as many as 29 high-profile programmes such as RAISE (Rebuild, Accelerate, Inspire, Sustain Excellence) for the executives of the public sector general insurance companies and 8 induction training programmes for the executives of public and private sector insurance companies in addition to the usual management development programmes. NIA also completed various research projects, some of the research projects viz. Insurance Protection Gap, Healthy Society, and Climate Resilience, Transition to Stakeholders Value Creation, Mutual Models in Insurance, A Perception of the Middle- and High-Income Millennials about the Need for Pension and their Retirement Preparedness The Professional Certification Courses viz. Diploma in Fire Insurance, Diploma in Reinsurance, and Executive Post Graduate Programme in Insurance and Management for a leading IT company were also launched and are successfully going on.

Our flagship programme, the two-year Post Graduate Diploma in Management achieved yet another milestone of 100% placement in Insurance, technology, and other allied sectors. The increasing demand for students from NIA is a clear indicator of the value created by us.

RAISE (Rebuild, Accelerate, Inspire, Sustain Excellence) Programme:

At the behest of the DFS-MoF, NIA has organized a comprehensive Learning and Development (L&D) intervention for public sector general insurance companies (PSGIC) called the RAISE Programme.

GM's Meet on Annual Training Calendar 2023-24 of NIA:

A virtual meeting of the General Managers of all public sector General Insurance companies, GIC Re & Agriculture Insurance Co. of India Ltd. was convened by NIA on 23.01.2023 to discuss the existing training procedures, understand and identify the gaps between the training currently being delivered vis-à-vis requirements of the companies and how improvements could be brought out to bring enhanced benefits to the companies and their employees.

Academic Programme - Post Graduate Diploma in Management (PGDM)

The two-year Post Graduate Diploma in Management (AICTE approved) is the flagship programme of the Academy. This programme is accredited by the National Board of Accreditation (NBA) and has also received MBA equivalence from the Association of Indian Universities (AIU). NIA is ranked by the National Institutional Ranking Framework (NIRF), Ministry of Education, Government of India in the band of 100-125 top management institutions in India in the year 2022. The course that is meant to develop future insurance leaders, attempts to impart knowledge, skills, and inculcate human values and professional ethics in the students through a curriculum that balances academic rigour with co-curricular and extra-curricular activities.

Registration and Orientation Programme (Batch 2022-24):

The Academy received applications from students with varied academic backgrounds viz. Arts to Engineering for its PGDM (Batch 2022-24) Programme. A total of 136 students were admitted for the Programme. A graphic representation of the academic profile of Batch 2022-24 is given in Figure- 1:

The Orientation Programme for the batch was held from 18th July to 30th July 2022. After a gap of 2 years this Programme was conducted offline on campus. A Welcome session was organized for the Batch with a warm welcome by Batch-In charge- Mr. Sandeep Pande followed by an address by Director, Mr. G. Srinivasan, Chair Professor (Non-Life)- Mr. Renjit Gangadharan, Chair Professor (Life)-Mr. P. Venugopal, Chair Professor (Financial Inclusion and Social Security)- Mr. V. Sathyakumar, Principal – Dr. Sanjay Mali closing with Vote of Thanks by Ms. Jayashree Sridhar, Faculty Member. This session was followed by a Campus tour to get the students well acquainted with Library, Gymnasium and Sports facilities, various Lecture Halls, and Insurance Laboratories.

A plethora of workshops viz. Students Introduction to Financial Management, Orientation Programme, Current Global and Indian Economics scenario, Time & Self-Management, Physical and Psychological wellness, Campus to Corporate, Harnessing Self through Cinema (Breakfast @ Cinema), Digital Technology & Insurance, A session by our own Alumnus about 'The MBA Journey and Beyond a talk on -How to pursue Research, Role of innovation in the Business environment- to encourage and sow Entrepreneurship ideas amongst students, show or art with Music for the Soul closing with an Industry HR Session.

The Academy specially scheduled an Awareness session on "Prevention, Prohibition and Redressal of Sexual Harassment of Students in higher educational institution", The students were also introduced to the details of various professional examinations conducted by the Institute of Actuaries of India, Chartered Insurance Institute (CII), London, and Insurance Institute of India (III), Mumbai.

Curriculum and Pedagogy:

The PGDM Course Curriculum is revised in the year 2022. It consists of core subjects and elective subjects. The two-year course comprises of six trimesters, three in the first year and three in the second year. Each trimester is of 12 to 14 weeks in duration with intense academic work for the students. The elective courses are offered during the second year. The students are required to opt for 1 elective course in each of the Trimesters IV, V and VI. At the end of the third trimester, the student is required to complete a compulsory eight-week Summer Internship Programme (SIP). The student is also required to work on a Major Research Project (MRP) in the IVth Trimester and submit a report. There is a Value Addition Project (VAP) in the VIth Trimester where a group of students present the descriptive research work to qualify himself/herself for the award of a Diploma.



Industry visits are organised during the conduct of technical Insurance courses for an add-on onsite experience coupled with theoretical knowledge. This helps in better conceptual absorption.

The pedagogy comprises:

- 1. Case Study / Quiz
- 2. Digital Library
- 3. Industry Interface
- 4. Classroom Lectures and Tests
- 5. Individual and Group Assignments
- 6. Individual and Group Presentations
- 7. Special lectures by corporate leaders / eminent personalities
- 8. Interaction with Senior Alumni working in specialised fields
- 9. On-the-Job Training in Insurance Companies

New Management courses and insurance elective options have been introduced wherein each student is required to opt for such Insurance electives alongside functional electives in Trimesters IV, V and VI. Non-Credit course on Banking is also introduced in the Curriculum revised in the year 2022.

Evaluation & Grading:

The performance of the students is evaluated not only through the term-end examinations, but also through continuous evaluation. Both the components viz. continuous evaluation and term-end examination have equal weightage and form an integral part of the course evaluation. The continuous evaluation comprises tests, quizzes, viva, home assignments, term reports, individual as well as group exercises, classroom participation, online problem-solving exercises, etc.

Guest Lectures:

It has been the practice of the Academy to bring the students face to face with eminent academicians and practitioners. Guest lectures are organised regularly to benefit the students from the experience and wisdom of the speakers. Eminent speakers from insurance companies and the corporate world frequently interacted with the students. These guest lectures form an integral source of learning for PGDM students. 

Examinations

The Academy continues to conduct the following examinations:

Insurance Brokers Examinations – The Academy is the only body in India recognized by the IRDAI to conduct the Insurance Brokers' examination. It is conducted online. During the year the academy conducted 20 (Twenty) examinations. 7992 appeared for the examinations, and 3773 passed the examination.

Insurance Brokers Training – The Academy is recognized by the IRDAI to conduct online training for Insurance Brokers since 2018. During the year 2859 candidates have taken the online broker's training from NIA's Online Broker Training Portal. Out of that, 2317 candidates have completed the Fresh training and 542 candidates have completed the Renewal of Licence training.

The Academy is a member of the Institute of Global Insurance Education (IGIE). IGIE conducts two web-based courses in General and Life Insurance through the resources at AICPCU. NIA is an authorized Centre for the above examination for General (Property Casualty) and Life Insurance as a foundation programme.

Ms. Hemlata Kolekar is a Controller of Examination.

Insurance Surveyors Examinations

The Academy and Insurance Institute of India are the only two bodies in India recognized by the IRDAI to conduct the Final Practical Test for Surveyors for the issue or renewal of license. It is conducted online. During the year the academy conducted 2 (Two) examinations. 104 candidates appeared for the examination and 103 passed the examination.

Ms. Jayashree Sridhar, Faculty Member and Dr. Ruchika Yadav, Research Associate are the Coordinators of this examination.

Webinars / Conferences / Workshops:

Workshop on Risk Financing & Insurance for Disaster Risk Mitigation and Building Climate Risk Resilience

As a part of National Planning for Disaster Risk Reduction (NPDRR) and Community-based Climate Risk Resilience Building objectives of our Government, the National Insurance Academy in collaboration with the National Institute of Disaster Management organized a Workshop on the topic of "Innovative Risk Transfer for building climate risk resilience" at Hotel President, Cuffe Parade, Mumbai, on February 21, 2023.



A group of 50 industry experts including risk managers and policymakers deliberated the key issues pertaining to the theme of the Workshop. Mr. G. Srinivasan, Director, NIA, delivered an Inaugural address, followed by a Special Address by Prof. Santhosh Kumar, Head, GIDRR & DRR Division, National Institute of Disaster Management who Role discussed the Government Building in Climate Risk Resilience. Mr.

D.V.S. Ramesh, Chief General Manager (Non-Life) IRDAI, deliberated on the Role of the Regulator in Disaster Risk Mitigation. Mr. Hadi Riachi, CEO, Swiss Re India, delivered a keynote address on the theme of the Workshop.

Subsequently, there were technical presentations held on various topics relating to the Implications of Climate Risk and Disaster risk mitigation through Insurance / Reinsurance and building climate resilience. Mrs. Madhulika Bhaskar, General Manager, GIC Re, and Mr. Shankar Gargipathy, CEO & Country Manager, Lloyd's India spoke on the Role of Reinsurers in Climate Risk Mitigation. Mr. Mihir Vora, Practice Head, Property & Large Risks, ASIBL elaborated the impact of Climate risks on Property Insurance, and Mr. Dinakaran, DGM, The New India Assurance Company Ltd. discussed the Necessity to Build Climate Resilience.

Dr. S. Doss, Faculty Member and Ms. Jayashree Sridhar, Faculty Member were the coordinators of the workshop.

Advanced Workshop in Engineering in collaboration with MUNICH RE

National Insurance Academy, Pune in collaboration with Munich Re had organized an "Advanced Workshop in Engineering" on 5th and 6th September 2022 from 10.00 am to 5.30 pm at NIA, Pune

This onsite Workshop took place for the first time after the Pandemic.



It covered a wide range of topics relating to Engineering Insurance. The topics included Risk Management in Construction sites, Tunnelling in Urban areas, ALOP, DSU and Design Defect Insurance.

Orientation Programme for Insurance Ombudsman

The Academy, on the advice of the Insurance Regulatory and Development Authority of India, organised a 5-day Orientation Programme from 28th November 2022 to 2nd December 2022 for all the 17 Insurance Ombudsman in India. There were participants from selected 8 Insurance Companies and from the office of the Council of the Insurance Ombudsman also.

The programme was inaugurated by Mr. Debasish Panda, Chairman, IRDAI. He presented the vision



of the Authority and the regulatory changes that are on the anvil.

Mr. P. Venugopal, Chair Professor (Life Insurance) was the co-ordinator of the programme.

Orientation Programme for Independent Directors on the Board of Insurance Companies

The Academy was privileged to be chosen by IRDAI to provide Training for all the Independent Directors on the Board of the Life and General Insurance companies in India. The programme covered important concerns relating to Corporate Governance and the technical aspect of Insurance. The experts on Corporate Governance, Insurance, and Finance engaged the participant Directors on all the issues and challenges relating to the role of Independent Directors on the Board in Insurance Companies. These programmes were very well received and appreciated by the participants.

During December 2022 and February 2023 two Programmes for Independent Directors of General, Life, and stand-alone health Insurance Companies were conducted. 34 Independent Directors of General, Life, and stand-alone health Insurance Companies participated in these two programmes.

Mr. P Venugopal, Chair Professor-Life Insurance, and Mr. Renjit Gangadharan, Chair Professor – General Insurance coordinated the programmes.

Deliberations on the "Future of Financial Markets"

Mr. G. N. Bajpai, Professor Emeritus and Member, Governing Board, NIA, Ex-Chairman SEBI and LIC of India addressed the esteemed audience on the topic: "Future of Financial Markets" at National Insurance Academy, Pune on 1st May 2022. Members of the NIA's Governing Board, Executive Directors from LIC of India and the General Managers from the GIPSA Companies and GIC Re along with the faculty members of the academy were present on the occasion.



In his address, Mr. Bajpai highlighted the role of Society, Politics, Economics, Technology, and the Environment in shaping and developing the Future Financial Markets. He emphasized that the Insurance Industry is in for an insurrection and highlighted the role of Insure-Techs, the Growing Complexity of Risks, and other Macro Trends in disrupting the Insurance Industry. His advice to industry practitioners about the Organization Design, Reengineered Business Model and Reorchestrated Revenue Model was extremely important in terms of becoming future ready organizations.

The participants had a great appreciation for the thought-provoking, engaging and insightful address by Mr. G. N. Bajpai.

Training Program on Crop Insurance for State Level Government Officials Sponsored by the Department of Agriculture & Farmer Welfare, Ministry of Agriculture, Govt of India

NIA successfully conducted a six-month training on crop insurance for the Department of Agriculture & Farmer Welfare, Ministry of Agriculture, Govt. of India. More than two hundred state officials from 22 states were trained in nine batches from August 2022 to January 2023. The training was organised in two phases.

- 1. Phase I: Five-day training for Senior State Officials on crop insurance
- 2. Phase II: Six-day Train the Trainer Program on Crop Insurance for District-Level State Officials

The participants for the second phase were identified from the first phase of training based on their performance in the first phase and their potential to become trainers. An online assessment was done at the end of each batch of training. Session profile, crop insurance handbook and reading material were prepared for both stages of training.

The first batch of training ended in the second week of October 2022. About state-level officials from 20 states were trained in six batches. The training was highly appreciated by the participants.

The second phase of the training was conducted from November 2022 to January 2023 in which about 70 Trainers were trained. A detailed completion report was prepared and submitted at the end of the training. The training was rated excellent and very good by the participants. The training was designed and coordinated by Dr Archana Singh, Assistant Professor, NIA in consultation with the Technical Support Unit of the Ministry. The ministry has proposed to form a committee to curate reference material and prepare a compendium of reading materials for the States on crop insurance in the near future.





Programme on Process Safety Management

National Insurance Academy organised a one-day course on Process Safety Management (PSM) in collaboration with the Centre of Excellence in Process Safety & Risk Management on 6th April 2022. The focus of the course was to build awareness on PSM. The course covered the basic theoretical background of PSM concepts, the importance of PSM and the tools which are available in the market to quantify and represent the impact of consequences resulting from process safety incidents.

Ms. Jayashree Sridhar coordinated the programme.

NIA-IIA-Marsh Hackathon 2022

National Insurance Academy, Pune, India InsureTech Association and Marsh McLennan have jointly organized the NIA-IIA-Marsh Hackathon 2022 to find innovative and actionable solutions developed by insuretech players to address India's insurance protection gap.

NIA-IIA-Marsh's hackathon has received 21 entries from companies/individuals. Two rounds of jury evaluation were conducted. After the screening of the applications, the shortlisted applicants presented the project in front of the jury. Based on the presentation in the second round, the jury selected the top three winners.

- o Rank 2: Medibuddy/ Dr Vineet Sikka Health Insurance (prize = Rs 3 Lakh)
- o Rank 3: iAssist Innovation Labs Health Insurance (prize = Rs 2 Lakh)

Dr. S. Doss, Faculty Member, Dr. Shalini Tiwari, Faculty Member, Ms. Jayashree Sridhar, Faculty Member and Mr. Barun Khan, Faculty Member are the co-ordinators for the Hackathon 2022.

Workshop/ Programme on (IFRS)

NIA had conducted customized workshops/training programmes on International Finance Reporting Standards (IFRS) with focus on roadmap towards IFRS implementation in Insurance Industry.

- A day long Workshop was conducted in association with Deloitte (India) and an IFRS Professional for GIC Re in July 2022
- A three-day customized training module was designed to cover the nuances of select standards such as IndAS, First-time implementation, investments, Leases and (Re)insurance contracts (in association with MP Chitale & Co.) in August 2022. This programme was attended by the officials of GIC Re and The New India Assurance Co. Ltd.



 Two-day knowledge sharing programme was arranged at NIA in December 2022 in association with KPMG India, where in participants from Public Sector Non-Life insurance companies have attended.

Certification Courses

Diploma in Marine Cargo Insurance



National Insurance Academy has introduced a "Diploma in Marine Cargo Insurance" with IUMI Accreditation. The Diploma in Marine Insurance is a three-month training programme spread over 11 weeks (3 hours per weekend) of online training and the course curriculum covers almost all the topics pertaining to Marine cargo insurance. This course would enable the candidates to acquire the necessary knowledge and information on Marine insurance underwriting and claims.

On successful completion of this course, the candidates would be well equipped with the requisite knowledge, skills, and experience to fulfil the responsibilities that their present or future employers might entrust them with. This would then lead to the development of a quality workforce thereby bringing higher levels of satisfaction amongst employees & employers.

This Diploma course in Marine Cargo Insurance equips individuals to foray into Marine insurance Industry i.e. As an Insurer, Reinsurer, Broker, Surveyor, Risk Manager or consultant. It also benefits Insurance / Risk management professionals handling Marine cargo insurance in Industries /Business. The program is designed to cater to varied job roles, from the entry level executives to mid-management cadre in Marine insurance. It also helps individuals to scale great heights in their existing career profile.

The program is delivered with assistance from eminent faculty members in the marine insurance field and industry experts. The teaching methodologies include presentations, and case studies from the global market.




Diploma in Reinsurance

National Insurance Academy has introduced a Diploma in Reinsurance to help interested persons to develop their knowledge and skills in the area of Reinsurance. The subject of Reinsurance is extremely important for insurance companies. It plays a major role not only in enhancing insurers' capacity to write business, but also in stabilizing its bottom line to a considerable extent. A comprehensive understanding of reinsurance will assist insurance personnel to become more effective professionals.



The sessions are conducted through Online mode. It is mandatory for the participants to attend the classes conducted

online to complete the course. Each Session is of 3 hours duration and are conducted on every Saturday from 02.30 pm to 5.30 pm. The pedagogical methods include lectures, presentations, case study, discussions, assignments, and exercises.



Final Examination for the course will be conducted online. Candidates will have to secure 60% in the Final Examination to be eligible to receive the Diploma in Reinsurance from NIA.

Diploma in Fire insurance

National Insurance Academy has launched a Professional Diploma in Fire Insurance. This Diploma aims to provide a holistic view of property risks, its assessment, market developments underwriting, reinsurance aspects, and claims management. The main objective of the Diploma is to provide in-depth knowledge and equip candidate's comprehension and increase exposure to understand about various aspects of Fire Insurance. The Diploma

is structured to enlighten the candidates on the conceptual and practical elements of Fire insurance.

The duration of the course is 3 months. However, the candidate can appear for the final examination after completing two months.



On successfully completing all the Chapters provided and passing of the final examination, the candidate will be awarded the "Diploma in Fire Insurance" by NIA.

Online "Certification Course in Proficiency in Crop Insurance (eLearning)"





The rapid growth of the crop insurance market in the recent past has also created a necessity to develop knowledgeable crop insurance professionals particularly. Insurance Executives, Government Officers handling crop insurance, Intermediaries, Surveyors & Loss Assessors, Weather Service Providers, and InsurTech Companies, etc. associated with every aspect of Crop Insurance value chain. Understanding this need, importance, and the demand of the market, the Academy launched this professional certification in Crop insurance course in 2020.

The course covers all the important aspects of crop insurance like the main features of PMFBY, Weather Based Crop Insurance (WBCIS), Yield Estimation using CCE,

Loss Assessment, Role of Technology in Crop Insurance and Agriculture Reinsurance, etc. The course has 7 chapters covering the above topics, a video session, additional reading materials, and a quiz. On completion of the course, the candidates shall have to appear for an online examination. The qualified candidates shall receive professional certification from NIA.


During the year 81 participants enrolled for the Certification Course in Proficiency in Crop Insurance (eLearning)

Dr. Archana Singh, Faculty Member coordinated the programme.

Course on Actuarial Science

The Academy launched an integrated "Post Graduate Program in Actuarial Science" covering the 'Core Principles' and the 'Core Practices' of the subjects of the Actuarial Profession. The course is intended to enable industry practitioners and fresh graduates to get exposure to actuarial and risk analytics while they pursue their professional careers.

The program began on 22^{nd} January 2022 with a batch size of 27. The profile of the students largely consists of insurance professionals, IT consultants, and students.



The core actuarial subjects are dealt by eminent actuaries and industry experts. There are interactions every month with CEOs and Senior Actuaries highlighting the industry requirements and sharing practical experiences.

The Syllabus of the course covers the following two levels of technical subjects:

Level 1: Core Principles - on the successful passing of 7 subjects the students would be awarded a 'Level-1: Certificate in Actuarial Science' (CAS).



Level 2: Core Practice - on successful completion of another 6 subjects including 40 hours of a major research project the students would be awarded the 'Certificate of Post-Graduate Program in Actuarial Science' (CPGPAS).

The classes are conducted online on the MS Teams platform during the weekends-Saturdays and Sundays, from 9.30 a.m. to 2.00 p.m. On-campus / virtual contact classes are conducted periodically.

The duration of the course at each level is of 8 months divided into 2 terms of 4 months each. Each term would covers 5 subjects. The final assessment consists of both internal assessments of continuous evaluation through quizzes, assignments and case studies and a written examination at the end of each term. The weightage for the internal assessment is 30% and external or final examination is 70%. The minimum passing percentage is 50% at an aggregate level.

10 candidates completed first term and appeared for the examination out of which 5 candidates successfully completed Level 1 i.e. Core Principles. NIA awarded Level-1: Certificate in Actuarial Science to the qualified candidates.

The programme is coordinated by Dr. S. Doss, Faculty Member.

Collaboration - Memorandum of Understanding (MoUs)

MoU with the International Financial Services Centres Authority (IFSCA)

The Academy and International Financial Services Centres Authority (IFSCA) has entered into MOU on 12th April 2022.

The purpose of this MoU is to undertake mutually rewarding partnership initiatives on Research and Training, seminars/workshops/ conferences and developing human resources of IFSCA.

Infrastructure at NIA

The Academy's infrastructure spread over 32 acres of land consists of Hostel Blocks, Administrative Block, Academic Block with 8 modern state-of-the-art classrooms, 2 Computer Labs (IT Parks), 8 syndicate rooms, 24 faculty rooms, Multi-purpose Hall, Library, Computer Centre, Kitchen, Dining Hall, Cafeteria and Reception, Auditorium, Meditation Hall, Gymnasium, Badminton Court, Swimming Pool, 5 Hostels with a capacity to accommodate 157 participants and 148 students. All MDP hostel rooms are provided with PCs with the internet, Intercom and Television with D2h connections. PGDM hostel rooms have LAN connectivity for students to use their laptops. The campus also has a residential complex of 64 units for its faculty and staff.

Library

The Academy's Library is one of the finest insurance libraries in India having the choicest collection of books, journal holdings in Insurance, Actuarial Science, Management, Economics, Finance, Law and Information Technology. The library is well equipped to serve the needs of the PGDM



students, MDP participants and the Insurance Industry. The purpose is to cater to all types of information needs of the users with reference to insurance and allied subjects. Stacking of the research publications is another value addition to the library. The library also has a collection on Literature, History and Personality Development. IT Infrastructure at NIA

The Academy has a Campus-wide Local Area network connecting 350+ computers, 7 servers, routers, switches, printers and other equipment. NIA uses Sophos Firewall for securing its network and Seqrite Endpoint security antivirus for desktops.

The Campus along with the Hostel is Wi-fi enabled. The Academy provides unlimited internet usage to students and employees through its high-speed WiFi facility anywhere in the us. Internet Facility is available for all users through their desktops and for PGDM students using their laptops. 170 MBps Bandwidth is made available for using the internet. The PGDM Students and the MDP participants are provided LAN connectivity in all the Hostel rooms.

The Academy has two IT-labs – IT Park (with 45 PCs) and Drucker IT Park (with 31 PCs) for hands-on training to the PGDM students and the MDP participants. All full-time faculty members are provided with Intel i5, i7 powered HP laptops/computers with Windows 8.1/10/11, Office 365, 24/7 internet connectivity, and staff with Intel i5 powered HP computers, Windows 8.1/10/11,



Office 365 for documentation, communication and as a productivity tool and 24/7 internet connectivity.

All the faculty and staff have access to network printers in their respective offices as well to high-speed photocopiers located in the Reprography Department. The students also have access to the network printer located in the Reprography Department.

There is a video conferencing facility which is used for Board meetings, educational activities and it is extensively used especially during the placement season. Software-based video conferencing unit is available for conducting meetings using Microsoft Teams, in hybrid mode (online as well as offline mode simultaneously).
