Management Development Programmes

On Campus / Online Programmes:

During the year 2021-22 due to continuous lock-down like conditions on account of the COVID-19 pandemic, the Academy seamlessly conducted remote learning by using high-quality education technology and digital capabilities on the MS Teams platform.

The Academy successfully conducted 226 Management Development Programmes (MDPs) out of which 212 were online and 14 were classroom training programmes. 5799 executives from public and private sector organizations including 114 overseas executives were trained during the year 2021-22.


Academic Programme - Post Graduate Diploma in Management (PGDM)

The two year Post Graduate Diploma in Management (AICTE approved) is the flagship programme of the Academy. This programme is accredited by National Board of Accreditation (NBA) and has also received MBA equivalence from the Association of Indian Universities (AIU). The course that is meant to develop future insurance leaders, attempts to impart knowledge, skills, inculcate human values and professional ethics in the students through a curriculum that balances academic rigour with co-curricular and extra-curricular activities.

Registration and Orientation Programme (Batch 2021-23):

The Academy received applications from students with varied academic backgrounds viz. Arts to Engineering for its PGDM (Batch 2021-23) Programme. A total of 101 students were admitted for the Programme. A graphic representation of the academic profile of Batch 2021-23 is given in Figure- 1:

The following series of webinars were arranged for graduate students between 12th to 22nd July 2021 through virtual mode due to continued disruption caused by the Corona pandemic.

1. Preparing for Management Studies
2. Overview of Insurance Industry
3. Career Opportunities in Insurance

The induction programme for the batch was held from 26th July to 14th August 2021. The programme was conducted online. An Icebreaking session was conducted by Batch-In charge to encourage cohesive interaction among the students. This was followed by a virtual tour of the campus including a visit to the various Insurance Laboratories in the campus.

There were a series of workshops on 'From Awareness to Creativity', Geopolitical and Economic Scenario, Use of Communication for Professionalism, Time Management and Self-Management, Awareness session on "Prevention, Prohibition and Redressal of Sexual Harassment of students in higher educational institution", Campus to Corporate, Business Opportunities in Post Covid Era, Music for the Soul, Future of Entrepreneurship and Start Ups, Insurance Marketing, MBA Through Dance (Mind -Body-Alignment), Introduction to Finance and Accounting Management. The students were also introduced to the details of various professional examinations conducted by the Institute of Actuaries of India, Chartered Insurance Institute (CII), London, and Insurance Institute of India (III), Mumbai.

Curriculum and Pedagogy:

The curriculum of the programme was devised, not only to inculcate knowledge and in-depth understanding of the different functional areas, but also to introduce the students to the techniques and skills required for a successful on the job performance. It attempts to develop managerial / professional skills in the students by fine tuning their innate abilities and attitudes. It also imparts the values required for leadership.

The curriculum consists of core subjects and elective subjects. The two-year course comprises of six trimesters, three in the first year and three in the second year. Each trimester is of 12 to 14 weeks duration with intense academic work for the students. The elective courses are offered during the second year. The students are required to opt for 1 elective course in each of the Trimesters IV, V and VI. At the end of the third trimester the student is required to complete a compulsory eight-week Summer Internship Programme (SIP). The student is also required to work on a Major Research Project (MRP) in the IVth Trimester and submit a report. There is a Value Addition Project (VAP) in the VIth Trimester where group of students present the descriptive research work to qualify himself / herself for the award of Diploma. Industry visits are organised during the conduct of technical Insurance courses for an add-on on site experience coupled with theoretical knowledge. This helps in better conceptual absorption.

The pedagogy comprises:

1. Case Study / Quiz
2. Use of Information Technology (viz. Blogs, Wiziq, Udemy)
3. Digital Library
4. Industry Interface
5. Classroom Lectures and Tests
6. Individual and Group Assignments
7. Individual and Group Presentations
8. Special lectures by corporate leaders / eminent personalities
9. On the Job Training in Insurance Companies

Evaluation & Grading:

The performance of the students is evaluated not only through the term end examinations, but also through continuous evaluation. Both the components viz. continuous evaluation and term-end examination have equal weightage and form an integral part of the course evaluation. The continuous evaluation comprises tests, quizzes, viva, home assignments, term reports, individual as well as group exercises, classroom participation, online problem-solving exercises, etc.

Guest Lectures:

It has been the practice of the Academy to bring the students face to face with eminent academicians and practitioners. Guest lectures are organised regularly to benefit the students from the experience and wisdom of the speakers. Eminent speakers from insurance companies and the corporate world frequently interacted with the students. These guest lectures form an integral source of learning for the PGDM students. The PGDM students had the privilege of being addressed by the following dignitaries during this year as per Table-5:





He was the Finance Minister of India from 1950 to 1956 and made significant contributions in the areas of economics as well as education.



The 23rd Annual C.D. Deshmukh Memorial Seminar was organized on 12th January 2022 on the Microsoft Teams platform. The theme of the seminar was “Reimagining Life Insurance Business Models in the Next Decade”. Eminent leaders from the Insurance industry were invited to deliberate during the panel discussions.

The Seminar provided a forum for the top industry experts to deliberate upon the fast-changing ecosystem and measures to be taken by the Life Insurance Industry to redefine themselves. The competition were under two categories:


Category A: Students (pursuing graduation/post-graduation/CAT/CMAT aspirants)

- New insurance covers for meeting ESG related liability risks.



Research Centre for Ph.D.

1. Mr. Narhar Nimkar, Ph.D. student of subject Financial Management supervised by Dr S Uma, has been awarded Ph.D. degree by Savitribai Phule Pune University (SPPU) in February 2022.
2. SPPU has approved transfer of Mr. Bhushan V. Raigaonkar from VAMNICOM to Academy in Financial Management area. Mr Raigaonkar will be supervised by Dr S Uma.
3. The PhD Centre has organized Six Monthly Progress Seminars for all the PhD Students as per SPPU Guidelines.
4. Online Workshops on 'Research Methodology' was organized for the PhD students, faculty members from Academy and other institutes, and practitioners from 5th to 9th October

2021. The workshop was facilitated by Dr Upinder Dhar, Vice Chancellor, Shri Vaishnav Vidyapeeth, Indore and Dr Sushama Chaudhari, Head of Academy's PhD Centre

5. Ten students are pursuing their Ph.D. Programme at Academy's PhD Research Centre.
6. First Round of Interviews for Ph.D. admissions (2021) in Financial Management and Marketing Management areas were conducted on 25th February 2022.
 - Mr. Mithilesh Kishor Gidage was selected by the Committee appointed by SPPU for Financial Management subject. Dr S Uma will be supervising the candidate.
 - Mr. Samuel John was selected by the Committee appointed by SPPU for Marketing Management subject. Dr S Doss will be supervising the candidate.
 - Academy has received admission approval letter by SPPU for the Mr. Samuel John and Mr. Mithilesh Kishor Gidage.

Centre for Research

The NIA's Centre for Research, which was established in 2019, undertook a variety of initiatives to improve the generation of research-based knowledge and foster the growth of the Academy's research ecosystem in the preceding year. The sections below provide additional detail about these:

Research Projects

In the academic year 2021–22, Ms. Suparna Bedakihale, Mr. P. Venugopal, and Mr. G. Srinivasan worked together to complete an in-depth research project on the difficulties encountered by life insurance companies in the appointment and retention of individual agents. The research was funded by NIA. It was conducted using both primary and secondary sources of information to compile its findings. The project was finished in September 2021, and the report was posted on the NIA's website for public need.

Assessment of Cyber Risk Exposures and Its Impact on Organizational Performance in India was another noteworthy study completed within the past year. It was conducted by Dr. S. Doss, Mr. G. Srinivasan, and Dr. Raveendran, an external expert. The initiative required the collecting of large amounts of primary information on Cyber risk exposures. TATA AIG General Insurance Co., Ltd. contributed partially to the project's expenses. The report was submitted in May 2021. The overview of these two studies is shown in Table 12 below.

Examinations

The Academy continues to conduct the following examinations:

During the year the academy conducted 9 (Nine) examinations. 6315 candidates registered for the examinations, 5883 appeared and 2910 passed the examination.

During the year 2749 candidates have taken the online broker’s training from NIA’s Online Broker Training Portal. Out of that 2441 candidates have completed the Fresh training and 308 candidates have completed the Renewal of licence training.

The Academy is a member of the Institute of Global Insurance Education (IGIE). IGIE conducts two web-based courses in General and Life Insurance through the resources at AICPCU. NIA is an authorized Centre for the above examination for General (Property Casualty) and Life Insurance as foundation programme

NIA’s Other Pursuits of Professional Excellence

Webinars / Conferences / Workshops:

Bharat Laghu Udhyaam Suraksha and Bharat Sookshma Udhyaam Suraksha”

IRDAI came out with three standardized policies under Fire line of Business during December 2020, which was to be offered by the General Insurance companies w e f 1.4.2021. NIA wanted

to be the first one to initiate the process of training the Insurance fraternity as a whole for the new products as it was likely to impact most of policy holders and other stakeholders in the country since most of the Fire policies were coming within the purview of these three products.

National Insurance Academy as a premier institution took the initiative to conduct the first online workshop for half day on 23rd January, 2021 to discuss and Explain the guidelines for standard products for Fire and Allied Perils for Dwellings, Small and Micro businesses, which was attended by close to 220 participants from the Industry. Seeing the success and the demand for such training, the second training was conducted on 17th April 2021.

Orientation Programme for Non-Executive Directors of Life, Non-Life Insurance and Stand-Alone Health Insurance Companies

The Academy was privileged to be chosen by IRDAI to provide Training to all the Non-Executive Directors of the Life, General and Health Insurance companies in India. The focus of the programme was to enable the Non-Executive Directors to perform their responsibilities in a diligent manner especially while balancing the interests of the shareholders with the interests of the policyholders. These programmes were very well received and appreciated by the participants

During April and September 2021 six Programmes for Non-Executive Directors of the Life, General and Health Insurance companies were conducted. 127 Non-Executive Directors of General Insurance, Health Insurance and Life Insurance Companies participated in these programmes.

Mr. Segar Sampathkumar, Chair Professor-General Insurance coordinated the programmes

Programme on Own Risk Solvency Assessment (ORSA) in Insurance Industry – RIMS:

The ORSA requires insurers to form their own view of the risk profile of the company and estimate the solvency capital. Each insurer has to assess their solvency capital, based on the nature, scale and complexity of the risks that they underwrite. ORSA has been the prerequisite for the Insurers in developed market where RBC or Solvency II has been implemented. Realizing the importance of this topic, National Insurance Academy and Risk & Insurance Management Society (RIMS), USA organized a two-day programme (On-line) on 28th & 29th June 2021 for the senior executives of insurance industry.

The programme covered the following key aspects of ORSA:

- The concept of ORSA and its relevance in ERM,
- Determining Risk Appetite in Insurance business,
- Allocation of Risk Capital using (standard/dynamic) capital assessment models across different types of risks exposures.
- Role of Stress testing and Scenario analysis in determining Solvency capital
- Future of Risk Capital models – ORSA simulation Lab - determining solvency capital under dynamic scenario.

The Programme was attended by Appointed Actuaries and CROs and Senior Executives from Insurance companies in India and Overseas. Risk Management Professionals including brokers. Overall, 52 executives have attended the programme.

Dr. S. Doss, Faculty Member coordinated the programme.


Programme on Artificial Intelligence in General Insurance Business (Non-Life):

Embracing Digital Innovation, particularly applications of Artificial Intelligence have increased exponentially across all industries in recent time. In the insurance industry, AI is transforming areas such as underwriting, customer service, claims management, marketing and fraud detection. Realizing the importance of AI in insurance business, National Insurance Academy has organized an exclusive programme on Applications of Artificial Intelligence in General Insurance business from 30th August 2021 to 1st September 2021.

The programme covered the following applications of Artificial Intelligence:

- Overview of Artificial Intelligence and It's applications in General Insurance
- Application of Machine Learning in General Insurance
- Computer Vision, Image Analysis and Deep Learning Analytical Techniques
- Applications of Block-Chain Technology in Insurance Business

- Fraud Analytics and Techniques in Insurance Business
- Use of Internet of Things (IoT) including Telematics in Insurance
- Impact of Technology on Claims Management

The course is intended to enable the industry practitioners and fresh graduates to get an exposure to actuarial and risk analytics while they pursue their professional careers.

The Academy received 47 applications for the program. A total of 38 applicants were selected to join the program after an interview.

The program began on 22nd January 2022 with a batch size of 27. The profile of the students largely consists of insurance professionals, IT consultants and students.

The core actuarial subjects would be dealt with by eminent actuaries and industry experts. There are interactions every month with CEOs and Senior Actuaries highlighting the industry requirements and sharing of practical experiences.

The Syllabus of the course covers the following two levels of technical subjects:

Level 1: Core Principles - on the successful passing of 7 subjects the students would be awarded a 'Level-1: Certificate in Actuarial Science' (CAS).

Level 2: Core Practice - on successful completion of another 6 subjects including 40 hours of a major research project the students would be awarded the 'Certificate of Post-Graduate Program in Actuarial Science' (CPGPAS).

The classes are being conducted online on the MS Teams platform during the weekends-Saturdays and Sundays, from 9.30 a.m. to 2.00 p.m. On-Campus / virtual contact classes would be conducted periodically.

The duration of the course at each level would approximately be of 8 months divided into 2 terms of 4 months each. Each term would cover 5 subjects. The final assessment would consist of both internal assessments of continuous evaluation through quizzes, assignments and case studies and a written examination at the end of each term. The weightage for the internal assessment would be 30% and external or final examination would be 70%. The minimum passing percentage would be 50% at an aggregate level.

The teaching faculty of the course have recommended a list of books on each subject for further reference and additional readings.

The programme is co-ordinated by Dr. S. Doss, Faculty Member.


Certification course on Principles of Underwriting in Life Insurance from 04.09.2021 to 06.11.2021

An online certificate programme on Principles of Underwriting in Life Insurance was conducted on Saturdays from 04.09.2021 to 06.11.2021. The programme covered the life insurer's most important risk management tool: underwriting. Underwriters are concerned with ensuring that the insurer retains risks knowingly considering its financial capabilities. Underwriting is essential to a competitive market. This is a basic level course which begins with concepts.

5 Participants from diverse fields of Life insurance viz. Brokers, insurance companies' working executives attended the programme. After completion of the course and successfully passing the evaluation examination all the 5 participants were awarded the completion certificate.

The programme was co-ordinated by Dr. K. Usha, Faculty Member.

Certification Course for Bancassurance from 21.8.21 to 23.10.2021



An online certificate course for Bancassurance was conducted on Saturdays from 21.8.21 to 23.10.2021. The programme covered the concepts of structure and management, regulatory framework and ethics, associated risks, governing laws, types and mechanism, documentation and selling of Insurance products through banks. This course primarily aimed towards the specified persons of banks distributing Insurance Products and Insurance Executives. The objective of this course was to equip the participant with the knowledge and skills that would enable them to distribute insurance products efficiently and effectively.

33 Participants from diverse fields of Life insurance viz. Brokers, insurance companies' working executives attended the programme. After completion of the course and successfully passing the evaluation examination all the 33 participants were awarded the completion certificate.

The programme was co-ordinated by Mr. Pradip Mahapatra, Faculty Member.

Certification Programme on Life Insurance Marketing from 18.09.2021 to 04.12.2021

An online certificate programme in Life Insurance Marketing was designed and conducted by NIA in the period 18/09/2021 to 04/12/2021 with the objectives of providing Life Insurance marketeers with the latest in Professionalism in Life Insurance, Products analysis, Financial Markets and Marketing strategies, Digital Marketing and Business Etiquette.

The program duration was for 3 hours each day on 11 Saturdays. The course was conducted by the industry experts, faculties and professional through case studies, discussions, interactions, quizzes for crystal clear understanding, building skills along with confidence and personality. Subjects pertinent to the programme objectives were Financial Need Analysis, Product Comparison & Analysis, Life Insurance Marketing, Mastering Business Presentations, Digital & Social Media Marketing, Mastering Marketing Tools, Corporate Life Insurance, Life Insurance Taxation, Feedback & Evaluation.

9 Participants from diverse fields of Life insurance viz. Brokers, IMF, Advisors and working executives attended the programme. One participant was from Sudan. After completion of the course and successfully passing the evaluation examination all the 9 participants were awarded the completion certificate.

The programme was co-ordinated by Mr. Anupam Jindal, Faculty Member.

Certification Course on General Insurance for Institute of Cost and Management Association (ICMA) -Batch I from 20.11.2021 to 02.01.2022


The Academy organized a professional certification course in General Insurance to the members of ICMAI. A total of 30 participants had attended the course. The course covered the core Principles and Practices of insurance, Motor Insurance, Fire Insurance, Marine Insurance, Health Insurance and Miscellaneous Insurance. The duration of the course was 26 hours.

NIA also organized two webinars on the topic of “Impact of Pandemic on the Insurance Sector – Opportunities and Challenges” and other on “Digitalisation of Insurance Business – Opportunities and Challenges”.

The programme was co-ordinated by Dr. S. Doss, Faculty Member.

NIA-RIMS USA Professional Certification Course on Risk Management:

The insurance industry is in need of competent Risk Management Professionals to manage the emerging challenges. There is a vast scope for professionals for Risk Management in Insurance Companies, Banks and Financial Institutions who require detailed knowledge and skill sets in Risk Management. Keeping this in view, the Academy entered into an MoU with RIMS, USA to conduct professional certification course on Risk Management. The course duration is 3 days of intensive workshop covering the topics viz. Analysing the Business Model, Designing Organizational Risk Strategies, Implementing the Risk Process, Developing Organizational Risk Competency and Supporting Decision Making in Insurance Industry.



The Academy in collaboration with RIMS, USA, conducted two on-line programs of the Professional Certification Course on Risk Management from 1st to 4th February 2022 followed by a MCQ based qualifying test two days after the completion of the on-line program. The participants were awarded a joint certificate by NIA, Pune and RIMS, USA. In all 50 executives attended the course.

The course co-ordinator was Dr. S. Doss.

Collaboration - Memorandum of Understanding (MoUs)

MoU with the India Insurtech Associations (IIA)

The Academy and The India Insurtech Association (IIA) has entered into MOU on 12th April 2021. The India InsurTech Association aims to facilitate the promotion of usage of technology across the insurance value chain in India. The association will promote new digital business models, build

collaboration between start-ups and all the other participants of the insurance industry - insurers, reinsurers, intermediaries, TPAs, service providers, investors and regulators. The association will represent the interests and be the voice of the InsurTech ecosystem in India.

This collaboration would entitle both the institutions for Training, Research and Education in the area of Insurance and Risk Management, Artificial Intelligence, Blockchain and Parametric Insurance.

MoU with National Institute of Bank Management (NIBM) Pune

On July 27, 2021, NIA and the National Institute of Bank Management (NIBM), Pune signed a Memorandum of Understanding (MoU). The purpose of this MoU is to develop a framework for exploring opportunities to support the Parties' mutual interests in the areas of executive training, higher education and research related to the Banking, Financial Services and Insurance (BFSI) sector. Under the MoU, NIA and NIBM will explore opportunities to collaborate with each other in the following areas:

- NIBM and NIA will endeavour to draw on each other's faculty resources as Guest Faculty for the Management Development Programmes (MDPs) as well as post-graduate programmes. This may be done based on the Programme contents and the faculty expertise available.
- NIBM and NIA can jointly organize seminars and workshops to leverage the expertise of NIBM in Banking and Financial Services and the expertise of NIA in Risk Management and Insurance. Such events will be co-branded and draw on faculty and other academic resources from both the parties. Such events can be related to the broader themes relevant to the BFSI sector.
- The parties can consider introducing student exchange programmes wherein post graduate students in NIBM and NIA would visit the other institute and undergo specialized modules. This would help the students from both the institutes to gain a wider exposure to the BFSI sector beyond the core expertise areas of the two institutes respectively. The modules will be designed and administered after mutual consultation and agreement.
- NIBM and NIA faculty members can undertake pure and applied research in collaboration based on their expertise and areas of research interests. For this purpose, the parties would give access to their institutional academic resources such as Library resources, databases and repositories of academic Journals.

MoU with Glasgow Caledonian University, UK

National Insurance Academy (NIA), Pune had entered a Memorandum of Understanding (MOU) with the Glasgow Caledonian University, U.K. on 13th August 2021. The collaboration would help the Academy to develop new or existing academic programs in the area of Insurance, Risk Management and Actuarial Science, through the exchange of skills and expertise, including student and faculty exchange.

The collaboration would promote interdisciplinary research between the institutions. It would also facilitate access to international networks and expertise in the areas of mutual interest between the

partners. Further it would provide opportunity to the students to pursue their higher education in UK.

MoU with CHRIST University, Bengaluru

The Academy has entered into a Memorandum of Understanding with CHRIST University (deemed to be University), Bengaluru on 3rd February 2022. The MoU covers broadly the following mutually beneficial activities:

1. Joint Research in Insurance and Risk Management.
2. Faculty and Student Exchange Programs
3. Organize seminars to create awareness about Insurance and the opportunities available in the insurance sector
4. Any other activities to be potentially beneficial to the insurance industry

The MoU shall be carried out within the framework of the respective laws and regulations of both the institutions and is not intended to create any legally binding rights and obligations. The MoU shall, initially, be for 5 (five) years.

The MoU was signed by Mr. G. Srinivasan, Director, NIA, as authorized by the Governing Board in its meeting held on 19.03.2019 and Dr. Anil Joseph Pinto, Registrar, on behalf of Christ University. The event was organized virtually on account of the disruptions caused by the ongoing pandemic.

All the Chair Professors, Faculty and Research Associates of NIA and the Faculty in Christ were witness to the proceedings.

Infrastructure at NIA

The Academy's infrastructure spread over 32 acres of land consists of Hostel Blocks, Administrative Block, Academic Block with 8 modern state-of-the-art classrooms, 2 Computer Labs (IT Parks), 8 syndicate rooms, 24 faculty rooms, Multi-purpose Hall, Library, Computer Centre, Kitchen, Dining Hall, Cafeteria and Reception, Auditorium, Meditation Hall, Gymnasium, Badminton Court, Swimming Pool, 5 Hostels with a capacity to accommodate 157 participants and 148 students. All MDP hostel rooms are provided with PCs with internet and Television. PGDM hostel rooms have LAN connectivity for students to use their laptops. The campus also has a residential complex of 64 units for its faculty and staff.

Library

The Academy's Library is one of the finest insurance libraries in India having the choicest collection of books, journal holdings in Insurance, Actuarial Science, Management, Economics, Finance, Law and Information Technology. The library is well equipped to serve the needs of the PGDM students, MDP participants and the Insurance Industry. The purpose is to cater to all types

of information needs of the users with reference to insurance and allied subjects. Stacking of the research publications is another value addition to the library. The library also has collection on Literature, History and Personality Development. Table-23 gives a brief profile of the information resources available in the library:

IT Infrastructure at NIA

The Academy has Campus-wide Local Area network connecting 350+ computers, 7 servers, routers, switches, printers and other equipment. NIA uses Sophos Firewall for securing its network and Seqrite End point security antivirus for desktops.

The Campus along with the Hostel is Wi-fi enabled. The Academy provides unlimited internet usage to the students and employees through its high-speed WiFi facility anywhere in the campus.

The Academy has two IT-labs – IT Park (with 45 PCs) and Drucker IT Park (with 31 PCs) for hands on training to the PGDM students and the MDP participants. All full-time faculty members are provided with Intel i5, i7 powered HP laptop/computers with Windows 8.1, Office 365, 24/7 internet connectivity, and staff with Intel i5 powered HP computer, Windows 8.1, Office 365 for documentation, communication and as a productivity tool and 24/7 internet connectivity.

All the faculty and staff have access to network printers in their respective offices as well to high-speed photocopiers located in the Reprography Department. The students also have access to the network printer located in the Reprography Department.

Internet Facility is available for all users through their desktops and for PGDM students using their laptops. 120 MBps Bandwidth is made available for using internet. The PGDM Students and the MDP participants are provided LAN connectivity in all the Hostel rooms. The laptops of the students are configured for using Local area network (LAN). The students can access internet using their laptops in hostel rooms. The MDP participants are provided PCs in hostel rooms for accessing Internet.

Wi-Fi Facility: Wi-Fi facility is available to students, participants, faculty and staff members for accessing internet using their laptops and mobile phones.

There is a video conferencing facility which is used for the Board meetings, educational activities and it is extensively used especially during the placement season. Software based video conferencing unit is available for conducting meetings using Microsoft Teams, in hybrid mode (online as well as offline mode simultaneously).

The Academy has provided Microsoft Office-365 to students, faculty members and staff members which includes Word, PowerPoint, Excel, Access, Teams, Outlook for e-mail which can be used for learning purposes. Microsoft Teams are being used for online learning and for conducting online meetings.

The Academy has adopted the digital platform seamlessly after the mandatory lockdown due to COVID19. The Academy conducted online MDP programmes and webinars using MS Teams platform. The classes and examinations for the PGDM students were also conducted online. The admission and placement processes were also conducted online.

The Academy's Intranet site is used for sharing information to staff members, faculty members and students.

The Academy's website has been well developed and provides all information about the Academy. This has helped greater transparency and making the Academy more visible.
