The validity of registration is one year.

The bidders are strictly advised to follow dates and time as mentioned in Key Dates of a particular tender. The date and time will be binding on all the bidders. The bidders are required to complete the stage within the stipulated time as per the schedule (Key Dates) to continue their participation in the tender. All online activities are time tracked and the system enforces time locks that ensure that no activity or transaction can take place outside the start and end dates and time of the stage as defined. 1. GENERAL TERMS & CONDITIONS

- a) The viewing of tender document will be available on all working days from 15.09.2025 to 30.09.2025
- b) It is mandatory for the bidder to quote for all the items mentioned in the tender.
- c) Bidders will carry out site survey to understand the network on the day of pre-bid meeting.
- d) Any queries raised in pre-bid meeting should be communicated to NIA on e-mail address ssdeshpande@niapune.org.in or amol@niapune.org.in on or before 22/09/2025.
- e) Rate should be clearly written in the columns specified [in blue boxes]. No advice of any change in rate or conditions after opening of the tender will be entertained.
- f) Tender shall remain open for acceptance by the NIA for a period of 90 days from the date of opening the commercial bid which may be extended by mutual agreement and the tenderers shall not cancel or withdraw the tender during this period/extended period.
- g) The rates quoted should be excluding GST. Applicable GST should be shown separately.
- h) NIA reserves the right to accept / reject / select more than one Agency and to annul the bidding process of any or all bids at any time prior to award of contract without thereby incurring any liability to the affected tenderers.
- i) The tender will be appraised by committee formed by NIA.
- j) In case of any dispute arising with regards to this tender or its conclusion, the decision of NIA shall be final.
- k) Cost Details and Validity: Prices quoted shall be in Indian Rupees, shall be firm and shall not be subject to exchange rate variations, fluctuations in

price, labour conditions and freights or any conditions whatsoever. The quoted Rate / Cost should be as per Annexure - B. The Bidder shall make note of the latest amendment to taxes and shall include the tax as applicable. The validity of the proposal against this Request for Proposal (RFP) should be valid for a period of 90 days from the date of opening the commercial bid.

- 1) Tax Deducted at Source (TDS) towards income tax calculated at the rate prescribed from time to time under the relevant sections of the Income Tax Act, shall be made from the bills of the Bidder and the amount so deducted shall be deposited with the Income Tax Department.
- m) The Academy reserves the right to accept or reject any or more bid(s) without assigning any reasons or cancel the tendering process and reject all bids at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder(s).
- n) The Academy reserves the right to amend or withdraw any of the terms and conditions contained in the tender document before accepting the tender or to reject any or all the tenders without giving any notice or assigning any reason and it shall not be bound to accept the lowest tender. The decision of the academy in this regard shall be final and binding on all.
- o) The Academy reserves the right to drop any item after technical evaluation and complete the bidding, without considering that/those item(s).

2. SUBMISSION OF TENDER

A. Technical Bid

The Technical and Commercial bids have to be submitted as per the prescribed formats given in Annexure-A.

Bidder will have to pay Rs.40,000/- (Rupees Forty Thousand only) towards EMD. e-Payment Gateway Facility are available on NIA e-Procurement Site, the vendors should have to pay EMD by e-Payment Gateway only. **DD Not accepted.**

Bids without EMD will be summarily rejected without any further reference to the bidder. No exemption will be given for EMD.

Please note that the Technical component of the Proposal should not contain any pricing information whatsoever on the services offered. The Technical bid should contain the details as given in Annexure-A.

B. Commercial Bid

The Commercial bid to be submitted as per the format given in Annexure B.

Bidders should submit the Bids strictly in accordance with the information given in the Annexure-B.

C. Opening of commercial bids:

Commercial Bids of only bidders who have been found to meet the **QUALIFICATION CRITERIA OF THE BIDDER** will be opened.

3. QUALIFICATION CRITERIA OF THE BIDDER

The Academy will evaluate the proposals and select the firm which satisfies the criteria listed below:

- A. The bidder should have a minimum average Annual Turn-over of Rs. **Fifty Lacs** in the last three financial years (2022-23, 2023-24, 2024-25) with profit in any two of these three financial years. CA certificate OR Audited Balance sheet and Profit and Loss account statement in support to be enclosed in the technical bid.
- B. The bidder should have experience of similar work for at least 3 years. Minimum 3 work order copies of LAN Cabling work in last three years 2022-23, 2023-24, 2024-25 latest till 31.08.2025 need to be enclosed in the technical bid. Similar work shall mean supply, installation, testing, and commissioning of structured LAN cabling (CAT6/CAT6A/optical fiber) involving racks, I/Os, patch panels, and related passive components and supply, installation and configuration
- C. Bidder should have service and support office in Pune.

of network switches.

D. Bidder should have minimum 2 network engineers on their roll. Letter on Company's letterhead specifying engineers details such as Name, Qualification, Experience (no. of years), certification to be enclosed in Technical Bid.

Bids from vendors who do not qualify based on the above criteria will be rejected.

Following supporting documents for fulfilling the qualification criteria will have to be submitted in Technical bid. (Compulsory Documents)

4. Scope of Work:

- 1. Installation and configuration of network switches at Hostel 3, Hostel 5 and Cottage
- 2. Installation and configuration of fiber switch at Drucker IT Park
- 3. All existing protocols configured on our existing switch needs to be configured on new switch. Other setup such as VLAN configuration, QoS, Security settings and other necessary configuration is required to be carried out by successful bidder.
- 4. Laying down fiber cable from
 - a. Drucker IT Park to Cottage,
 - b. Drucker IT Park to Hostel 4 First Floor,
 - c. Extension of existing fiber cable from Drucker to Hostel 5 Boy's Wing Reception.
- 5. Laying outdoor CAT6 cables
- 6. Laying down indoor CAT6 cables considering 2 LAN points per room in Hostel 5 and Cottages and Single LAN Point in Hostel 3 in each room additionally some cables need to be laydown in Reception area of hostels, Lobby, VIP Rooms.
- 7. Removal of existing faulty cables and fittings in hostel 3, Hostel 5 and cottage.
- 8. Civil Work (digging/trenching etc.): Civil Work is required to be carried out as per the guidelines given by Engineering Department.
- 9. Fiber Splicing

- 10. Electrical points and cabling will be carried out by NIA engineering Department.
- 11. Supply of CAT6 / CAT6A UTP cables (as specified) with all necessary accessories.
- 12. Laying of cables in conduits, raceways, or trunking with proper tagging and identification.
- 13. Supply and installation of I/O ports, faceplates, back boxes, and patch cords.
- 14. Termination of cables at Information Outlets (IOs) and Patch Panels.
- 15. Installation of 24/48 port Patch Panels in suitable wall-mount/rack-mount network racks.
- 16. Dressing, routing, and labeling of cables as per structured cabling standards.
- 17. End-to-end testing of Fiber and all LAN points with certification reports
- 18. Commissioning of the complete cabling network, ready for integration with active network devices.
- 19. **Testing:** Testing by using attenuation tester such as Fluke Meter for new network points. Further, discovered faulty network points should be rectified and retested.
 - Testing of Fiber Cabling: Verification of desired network speed.
- 20. **Implementation time:** The above work should be completed within 45 days after receiving the Purchase Order.

21. Deliverables after Installation:

- > As-built drawings of cabling layout.
- Test and certification reports of all installed LAN points.
- ➤ Warranty/guarantee certificate for supplied components
- > After installation, successful bidder is required to complete the registration process with D-Link for warranty purposes.
- Successful Bidder should provide all items serial numbers in Excel format.
- Items shall be supplied in compliance to the specifications mentioned in the commercial bid format of the tender.
- All the items supplied should be of original manufacturer D-Link.
- Suggested product should not be end of Support and end of Sales within next five years from the date of supply. During the warranty period if any

product is declared end of life or end of support, the bidder should supply next higher model free of cost.

- The bidder shall offer on-site comprehensive warranty for at least three (03) years for all items mentioned in Annexure B, from the date of successful installation and commissioning at the designated location. NIA is not liable to pay any extra charges on any account during the warranty period. All software updates and firmware updates will be provided during the warranty period without any extra charges.
- All loading, Unloading and transit insurance of material to be delivered is in the bidders scope

5. Delivery

- a) All the items are required to be delivered within fifteen (15) calendar days from the date of issue of supply order. However, the bidders have an option to submit the best delivery time, but in any case, the delivery should be before 15 days from the date of issue of supply order by NIA.
- b) NIA has the right to cancel the order if the items are not delivered in time.
- c) The material shall be inspected on receipt at site and bidder shall be responsible for any damage during the transit of material.
- d) In case of delay in delivery of materials or completion of work beyond the stipulated schedule the successful bidder shall be liable to pay Liquidated Damages (LD) at the rate of 0.5% of the total contract value (excluding tax) per week of delay, subject to a maximum of 10% of the total contract value.
- e) Delays arising out of reasons beyond the control of the contractor (force majeure conditions such as natural calamities, war, strikes, acts of God, etc.) shall be considered for extension of time without penalty, subject to adequate proof being submitted and accepted by NIA.
- f) The bidder shall not arrange part shipments and/or trans-shipments without the permission of NIA. The insurance cover including insuring the goods against the loss or damage incidental to manufacture or acquisition, transportation, storage and delivery/Installation & Commissioning shall be obtained by the bidder in his own name and not in the name of NIA. NIA will as soon as possible but not later than 30 days from the date of arrival of goods at destination shall notify the bidder of any loss or damage to the goods.

6. Warranty

- a) The OEM shall offer on-site comprehensive warranty of all items for **three years** from the date of successful installation and commissioning at the designated location & shall cover each and every part of the equipment including parts having limited life etc. NIA is not liable to pay any extra charges on any account during the warranty period.
- b) The bidder shall pay to NIA such compensations that may arise by reasons of the warranty therein contained but not attended by the bidder. Any part or parts

fail or proved defective within the on-site warranty period specified above, owning to defect in design, material or workmanship, the bidder shall have to replace them at the place of installation without asking for any charges.

7. After Sales Services

- a) The bidder shall ensure to render after sales services during the warranty period to the satisfaction of NIA.
- b) The bidder will depute their engineer within four hours to attend the service call received in writing from NIA.
- c) Replacement of faulty items should be done within one day.

8. EARNEST MONEY DEPOSIT (EMD) and Performance Security

- a) Bidders are required to submit Rs.40,000/- (Rupees Forty Thousand only) as EMD for the bids. e-Payment Gateway Facility are available on NIA e-Procurement Site, bidders should have to pay EMD by e-Payment Gateway only. **DD Not accepted.**
- b) The EMD is non-interest bearing and is refundable to unsuccessful bidders after signing of the Contract by the successful bidder. No exemption will be granted.
- c) The Successful bidder has to submit Bank Guarantee of 5% of the price from Commercial bank which should be valid for a period of 60 days beyond the completion of all contractual obligations of the supplier including warranty. Performance security is to be forfeited and credited to the Academy in the event of breach of contractual obligation by the supplier, in terms of relevant contract.
- d) The successful Bidders EMD will be returned after getting the Bank Guarantee.
- e) The EMD will be forfeited if a bidder withdraws his bid during the period of validity.

9. PAYMENT TERMS:

- a. The 60% payment of total bill will be made by NIA by /RTGS/NEFT for which the bidder shall send bills in duplicate (original + copy) after delivery of material.
- b. The 40% payment of total bill along with EMD deposit will be released to bidder
 - A. after one month from the date of installation and commissioning of Switch and Network cabling
 - B. After testing of switch configuration and network cabling
 - C. On submission of Bank Guarantee.
 - D. After submission of documents mentioned under point no. 21

10. INDEMNITY:

The Bidder will indemnify NIA to the extent of direct damages against all claims, demands, costs, charges, expenses, award, compensations etc. due to Bidder's violation of any patents and copy rights.

11. JURISDICTION:

In the event of any dispute the legal matter shall be subjected to the jurisdiction of Pune Court only.

12. FORCE MAJEURE:

In the event of any unforeseen circumstances directly interfering with the supply of goods/work/service arising during the execution of order such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, earthquakes, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Bidder shall, within a week from the commencement thereof, notify the same in writing to NIA with reasonable evidence thereof. Either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other.

13. MISCELLANEOUS:

- a) In case the Bidder is not able to accept the contract after it is awarded to him or if he is not able to do the job after accepting the contract, he will be liable to pay the damage to NIA including the extra rate, which NIA will have to pay to any other party for getting such work done.
- b) Bids should be in clear words, categorically mentioning each and every terms specifying the rates, etc. Any kind of ambiguous/obscure/unclear terms would lead the firm's bid being disqualified.
- c) NIA reserves the right to Add, Modify, Relax or waive any of the conditions stipulated in the bid document wherever deemed necessary.
- d) NIA has the right to accept item-wise prices separately or the financial bid in total and /or alter the given quantity numbers.
- e) In the event of dispute, the decision of NIA shall be final and binding on both the parties.
- f) NIA does not bind itself to accept the lowest or any other offer and reserves the right to accept or reject any or all the offers either in full or in part without assigning any reason.

- g) Any publicity by you in which the name of NIA is associated should be only with the written permission of NIA.
